

Drama Club Update - Grades 6-8

This year's play will be Ronald Dahl's Willy Wonka Kids. We are planning lots of upbeat dancing, singing, and of course acting. There are lots and lots of parts!

Attached to this sheet, is a schedule of play practices. Please take a few moments to review it. Due to the ever increasingly busy afternoon schedule of our middle school students, most of our practices will take place before school on Tuesday and Thursday mornings. Attendance is mandatory.

Also be aware that all middle school students will be expected to keep their grades and conduct up. Therefore, students must maintain a C average, have no conduct and effort grades below a 3 and serve no detentions.

Auditions will be in December (see below). Be prepared at auditions to run some lines. Some parts (not all) require a singing audition. This is a no-cut play, all middle school students will be in the main cast. If your student is interested in the play but nervous about auditions, please have him or her speak to Mrs. Rogge and she'll explain the process.

Dues this year are \$25. This year we are asking for the dues to be paid upfront so that we can begin purchasing props, costumes, etc.
